These firms are all registered with their local oversight bodies (including the PCAOB) and, consequently, are subject to rigorous annual quality controls.

The operation of the ‘*Mazars North America Alliance*’ will be conducted by internal teams to ensure the highest level of coordination and management during the initial launch and assignment process in North America. The current modus operandi will neither be subject to change for existing clients nor for the responsible teams.

Mazars en Amérique du Nord: la création ‘Mazars North America Alliance’.



Nous sommes très heureux de vous (annoncer une nouvelle étape importante dans le développement de Mazars grâce à la création d’une alliance en Amérique du Nord, «Mazars North America Alliance».

Composée de Mazars et de cinq grands cabinets d’audit, Tax et conseil aux Etats-Unis et au Canada, «Mazars North America Alliance» renforce considérablement la présence de Mazars sur le territoire nord-américain en permettant un accès à plus de 16 000 professionnels basés au Canada et aux Etats-Unis et en offrant une couverture nationale dans ces deux pays.

Cet accord change véritablement la donne pour Mazars. Nous avons déjà une présence aux Etats-Unis et au Canada dans le périmètre intégré mais l’alliance renforce significativement nos capacités en Amérique du Nord et nous permet de développer notre capacité de service pour mieux servir nos grands clients français et internationaux dans la région.

Pour les groupes avec lesquels nous intervenons déjà aux Etats-Unis et/ou au Canada, la mise en place de l’alliance ne modifie pas les modalités d’exercice de notre mission dans cette région ni les équipes en charge de la mission.

Mazars a toujours fait le choix de développer sa présence internationale par la voie de l’intégration juridique, financière et opérationnelle de ses membres pour assurer un pilotage et une coordination forte des missions internationales. Nous restons et resterons fidèles à ce choix. En Amérique du Nord, le choix complémentaire d’une alliance répond à un seul objectif : apporter à nos clients internationaux une force de frappe sur deux très grands marchés sans bouleverser les équilibres du groupe Mazars, en conservant notre ADN et sans l’exposer aux risques significatifs que ces marchés représentent dans nos métiers.

Avec cette alliance, Mazars compte aujourd’hui 40 000 professionnels au service de ses clients dans le monde entier : 24 000 professionnels dans 89 pays et territoires via le partnership intégré unique de Mazars, et 16 000 professionnels aux Etats-Unis et au Canada via «Mazars North America Alliance».
