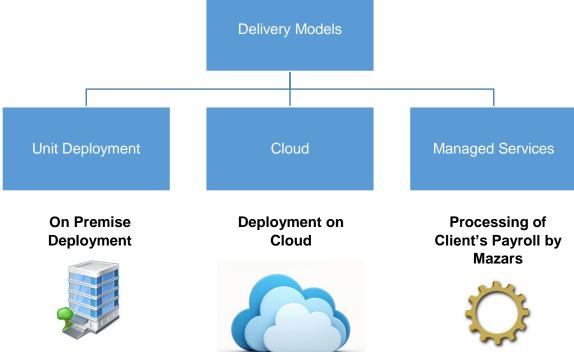

[Payroll Process]

This Payroll module is the main hub of the ePayroll Accounting solution, maintaining an Employee's Allowances and Deductions and processes the monthly salary of the employees. This module processes all types of transactions to prepare the final payable salary to the employees.

Users can run multiple 'Draft Process' of the Payroll for verification before a 'Final Process' of Payroll.
